A Message from the Mayor

It's Good to be back! I have enjoyed serving our community and I am very proud of the services we provide and grateful to be a part of those services.

Many residents have asked about Central Avenue and when it will be paved. We realize that it is in poor condition and will pave that road from Broadway to Walden Avenue. We have been awarded a TAP Grant from New York State that will provide new sidewalks from Broadway to Walden Avenue with handicapped access points on all street corners, new stamped concrete sidewalks in the Central Business District and other related work. This grant is similar to the TAP grant that we were awarded several years ago that provided new sidewalks Aurora Street and Broadway, saving our local taxpayers hundreds of thousands of dollars. This work is scheduled to be done in 2026 and as with any construction project, we ask for your patience and understanding during that time. The Village of Lancaster will completely pave Central Avenue in 2027 after the completion of the TAP grant work. It makes little to no sense to pave now when so much of the road will be affected by the TAP Grant work. The last time Central Avenue was completely paved was in the '90s and it is long overdue however following this plan will have great results. We will continue to patch and keep the road safe for all until it is completely resurfaced.

TREE TALK: TREE CARE AND RESPONSIBILITY IN THE VILLAGE

The Village of Lancaster is proud to maintain an urban forestry program, with more than 3,800 street trees forming a vital part of our community's green infrastructure. Each tree is part of a larger, carefully managed system that enhances public health, environmental quality, and neighborhood beauty.

As part of our ongoing commitment to a healthy urban forest, the Village is also working to correct planting and maintenance. This includes removing trees that were poorly sited, improperly pruned, or planted without consideration for long-term growth. Through our Tree Management Plan, we're making smarter, more sustainable decisions—from species selection to planting location and maintenance protocols—so that Lancaster's street trees thrive for generations to come.

WHY DO WE PRUNE TREES?

Pruning trees is important for both safety and tree health, and a single pruning can often achieve multiple goals.

Pruning for safety removes branches that could fall and cause injury or property damage and also clears low branches to improve visibility and allow safe passage for pedestrians and vehicles. For tree health, pruning removes dead, damaged, or insect-infested branches, improves airflow to help prevent pests and diseases, and encourages strong structure so trees can better withstand storms.

WHAT IF I WOULD LIKE TO HAVE A TREE PLANTED IN THE RIGHT OF WAY?

Residents may request a tree be planted between the sidewalk and the curb in municipal right of way by completing a form on the village website. An inspection of the planting area by the Village Arborist and Forestry Team is required before any planting decisions are made.

WHAT SHOULD RESIDENTS DO— OR NOT DO?

We encourage you to help support the health of trees in your neighborhood, especially newly planted ones. Watering is especially important during dry periods—young trees need about 15–20 gallons of water once a week during their first two to three growing seasons. Slowly soak the soil around the base of the tree to ensure deep watering. You can also help by:

- Keeping lawnmowers and string trimmers away from the base of trees to prevent damage to bark
- Avoiding piling mulch directly against the trunk (keep it a few inches away)
- Reporting any signs of disease, pests, or damage to the Village

We ask you to never prune, remove, or plant street trees on their own. This includes not attaching swings, signs, or decorations to trees, or causing intentional harm to prompt removal. These actions can damage trees, pose safety risks, and violate Village regulations.

WHO IS RESPONSIBLE FOR PRUNING TREES IN THE RIGHT-OF-WAY?

Responsibility is shared between utility companies and the Department of Public Works, depending on the situation. Utility companies prune trees around power lines to maintain safe electrical clearance, which is legally required and helps prevent power outages and fire hazards. However, when utility pruning is delayed or done improperly, it can unfortunately lead to unsightly trees and long-term damage to tree health.

The DPW is responsible for pruning trees within the public right of way for safety, visibility, and overall tree health. All DPW work is conducted in consultation with the Village Arborist and follows best practices for urban tree care.

WHY MIGHT A TREE BE REMOVED?

A tree may be removed if it is dead, diseased, structurally unstable, interfering with utilities, damaging infrastructure, or poses a significant safety hazard. Tree removals are only made after inspection by the Village Arborist or Forestry Team. Whenever possible, the DPW replaces removed trees, considering site conditions and species suitability to support a resilient canopy.

A Note from Trustee O'Brien Grants Committee

It has been an exciting and busy few months since I joined the Village Board as trustee on April 7th! If you watch our Village Board Meetings, either in person or online, you have a sense of what I have been working on as chair of the Grants and Climate committees and co-chair of the Finance & Claims committee. From day 1, it was abundantly clear that there was a lot to do. I would not have been able to pick up these projects so quickly without the tremendous support of Sustainability Coordinator Amy Stypa and Clerk-Treasurer Michael Stegmeier, as well as everyone in the Village Office.

On the Grants Committee, one of my responsibilities has been implementing the NY Forward Small Project Fund (lancastervillageny.gov/smallprojectfund/). Not only did I need



to educate business and property owners in the grant area and encourage them to submit projects before the deadline, I also had to form a selection committee made up of stakeholders and residents to identify which projects would receive a piece of the \$270,000 in available funding. In the end, we received 20 applications for almost \$1.5 million in projects! These applicants saw an opportunity to continue the revitalization of our Village and all told were willing to invest nearly three quarters of a million dollars of their own money to make it happen. Thank you to all who submitted applications. Congratulations to all of the funded projects; the selection committee had a difficult task!

On top of that, I had the privilege of participating in the Village of Lancaster's first ever community tree planting event, attending a tree dedication ceremony for five families on West Main Street, walking in the Memorial Day parade, working with consultants, engineers, and other subject matter experts on additional, grant-funded projects, and have started looking at future opportunities to fund additional important projects in our Village. There is plenty of more work to be done, and I am grateful to have the opportunity to do it on behalf of such a supportive community!



Milling took place starting on Monday July 7th and Tuesday, July 8th.


Paving is expected to begin the week of July 21st.




Legendary Rides






Fourth of July

Hello from your Village of Lancaster Fire Department!

Please keep the following tips in mind as you and your family enjoy the summer season.

- Use grills, barbecues, and outdoor cooking appliances at least 3 feet away from your house in a safe and designated area away from flammable materials.
- Keep a close eye on the grill or cooking area and never leave it unattended.
- Ensure proper disposal of charcoal and ashes in a metal container, allowing them to cool completely before disposal.
- Stay hydrated by drinking water steadily, even if you don't feel thirsty. Avoid sugary, caffeinated and alcoholic drinks.
- Stay cool by taking frequent breaks in the shade or indoors in an air-conditioned space.
- Stay connected by checking on others and asking for help if you need it. Make sure pets have access to fresh water and shade.
